



Terms & Conditions – Have Your Portrait Featured on Sky Arts (the “Competition”)

Eligibility

1. This Competition is open to all primary school teachers (including Home Schoolers) who are currently teaching in primary schools in the UK, Isle of Man, Channel Island or Republic of Ireland.

Entry Period

2. This Competition opens at 0900 on Wednesday 11th January 2023 and closes at 2300 on Friday 24th March 2023 (the “Competition Period”).

Entry Requirements

3. To enter this Competition, you need to share a photograph of a portrait created by a pupil in your school on your school’s public account on Instagram, Twitter or Facebook using the #AccessAllArts hashtag or email a photograph to accessallarts@nationalschoolpartnership.com
4. The entry criteria are:
 - a. The subject of the portrait should be an adult who is linked to your school. This could be a teacher, Head Teacher or member of the support staff etc
 - b. The portrait may be created in any medium
 - c. The portrait must have been created by a pupil currently in your school
 - d. The child must be aged between 5 and 11 years old
 - e. Teachers must have permission from the school and written permission from both parents that their child may take part in the competition before submitting the photograph, including before posting the photograph on social media. Information should be provided on circumstances if only one parent gives consent. Sky will require proof of these permissions should the picture be selected.
5. Teachers may submit as many portraits as they like if they meet the specified criteria.
6. Sky has the Rights to feature all entries On Air, online and through e-comms.
7. Entries sent in through agents, third parties, websites or multiple accounts will be disqualified. Promotion of Entries through third party websites (other than the host website) is prohibited. The Promoter reserves the right to not award prizes if qualifying criteria is not met and the right to select replacement entry into the competition element of the Promotion.

Prizes

8. The winners will have their portraits featured on Sky Arts Portrait Artist of the Year Celebrity Special and/or in a short on air feature on Sky Arts.
9. The prize does not include any other service or item not specifically described above.



Winner Selection and Notification

10. 160 portraits will be selected. 60 will be chosen to feature on Sky Arts Portrait Artist of the Year Celebrity Special and 100 which will be featured in the Sky Arts on air gallery.
11. The winning portraits will be selected by a panel made up of Sky Arts, We Are Futures and Storyvault Films and the judges from Sky Arts' Artist of the Year series, during the week of 27th March 2023, from all eligible entries received during the Promotional Period.
12. Winners will be selected based on the following criteria:
 - a. Creativity (originality and how much the piece of art stands out)
 - b. Skill and technique (use of colour, texture, materials and mark making)
 - c. Detail (presentation, correct proportions, clear lines and shapes)
 - d. Each portrait will be judged according to the age of the pupil and winners will be selected across a range of age groups.
13. The winners will be notified by direct message or by email by Friday 7th April 2023.
14. The winners will need to send a high-resolution image of the portrait to accessallarts@nationalschoolspartnership.com by Monday 17th April 2023.
15. If the winner cannot be contacted within a reasonable time period or is not able or available to accept the prize for any reason which is beyond the Promoter's reasonable control, then the Promoter reserves the right to award the prize to another entrant.

Data Protection

16. Any entrant data collected will be used for the purpose of administering the promotion and contacting the winner to notify them of the prize.
17. If you are a winner you agree that the Promoter may use the name of your school for post-event publicity purposes without additional remuneration.
18. The winning portraits will feature on air as described along with the first name of the child, their age and the name of the school.
